(a) may sign or stamp the permit before the permit is issued rather than signing or stamping the permit at the time that it is issued. *Wis. Stat. §167.10(3)(fm).*

## CONDITIONS & RESTRICTIONS

**This permit may only be issued based on the following conditions or restrictions:**

1. The Town of Forestville shall not be liable in any civil action, for any accident or injury caused during the transportation, handling, storage or use of said fireworks or for the sole reason of issuing a fireworks permit.
2. The Town Chairman, Southern Door Fire Chief or their designees reserve the right to cancel/call off any permitted fireworks display for reasons of health or safety.
3. **A permit cannot be issued to individuals who are minors.**
4. Permit Holder is responsible to return this permit request back to the Town Clerk of Forestville or their designee by **one week prior** to any display of fireworks.
5. No firework displays may be launched over neighboring properties specifically not owned by the requestor/permit holder without first getting permission from said neighbor or property owner.  
**(Permission Requires Signatures below)**
6. Home Displays: Permit Holder is responsible for damages or injuries to person(s) or property and should have appropriate liability insurance coverage for holding such an event. Permit Holder is responsible to check with their insurance provider for coverage.
7. Permit Holder is responsible for cleanup of neighboring properties from any and all debris caused from the fireworks display.
8. (Over Land) This permit becomes void if wind conditions exist greater than **8 miles per hour** prior to display being set off over land.
9. (Over Water) This permit becomes void if wind direction changes to cause display of fireworks to blow back over land and wind speeds exist greater than **8 miles per hour** prior to display.
10. Sky Lanterns are not permitted.
11. This permit becomes void during periods of extreme dry conditions, winds exist of greater than 8 miles per hour, or when other fire hazard warnings have been issued by the DNR, Fire Department, Emergency Management, County Government or Local Town Government.
12. Public Displays: If the permit is for fireworks of a larger size, such as the kind used for public displays, then a copy of the permit must be given to the Southern Door Fire Department and Door County Sheriff's Department two days prior to the authorized display. The Town of Forestville may require a Permit Holder to file an Indemnity Bond in the name of the TOWN OF FORESTVILLE, in the amount of \$\_\_\_\_\_, that will indemnify other person(s) for any injuries to person(s) or property arising out of the use of **display fireworks**.
13. This permit only covers the authorized use for the date and time listed on the permit. Additional firework displays require individual permits. (No alternate dates are allowed by state law, WI Stat. §167.10(3)(f) 4.)
14. Please be mindful and respectful of your neighbors and our American Combat Veterans who may be suffering from PTSD.
15. This permit may be revised at any time by the issuing authority.
